#### **About LUMC**

- Learnington United Mennonite Church is located in the heart of Learnington near schools and residential neighbourhoods, and our facilities are utilized by a variety of local organizations, ranging from a snack program for a local school to after school programs hosted by community organizations.
- Current weekly attendance averages around 150 people, not including 175 who worship with us through our online broadcast from the Learnington Mennonite Home, a nearby seniors residence.
- Our services are broadcast on YouTube and are viewed on average 250 times/week.
- We have an active and growing Sunday School program. We also have weekly Jr & Senior youth programming.
- LUMC is closely connected to both a Christian High School (UMEI), as well as a seniors home (Learnington Mennonite Home), in addition to local charitable organizations, including MCC's Thrift on Mill, Gleaners, and the Bridge, a resource centre and home for at-risk youth.
- Learnington is a small city located within a rural agricultural community on Lake Erie. We are located in the south-western corner of Ontario, just a 45minute drive to Windsor and the Detroit border. Detroit has a major airport and is one of the fastest growing tech sectors in the US
- Learnington enjoys close proximity to national and provincial parks, as well as educational and health facilities, including a local hospital in Learnington. We are located in an economically vibrant and expanding region with many opportunities for spousal employment.

- Share in the responsibility of providing resources to the church community
- Create and support educational opportunities that will inform and shape faith within the congregation (ie Adult Sunday School, small groups, young adults, parents of young children, prayer groups, and/or Bible studies, etc.)
- Connect with and support the work of the Children's Ministry Coordinator

## Spiritual & Faith Formation

- Promote personal, educational, relational and spiritual growth in the lives of the people of our congregation
- Lead/Co-lead catechism and membership classes and the baptismal process
- Promote LUMC as an anchor of faith formation in our community.
- Provide support and oversight to the Jr & Sr Youth Programs
  - Encourage connection and activities among MCEC and other faith groups
  - Encourage and nurture leadership gifts of youth
  - Equip and support adult leaders and sponsors for the youth ministry programs
- Provide leadership and pastoral support to various groups within the congregational life of LUMC (including but not limited to: youth, College & Careers, young families, etc.)

## Discipleship & Witness

- Support the Mission Hub and its activities as sponsored by the church
- Support participation in Mennonite Church Canada, MCEC, and other national, provincial, and local cluster activities
- Work with the pastoral ministry team to coordinate meaningful worship experiences at LUMC
- Preach on Sunday mornings once a month
- Support and develop the ministry of worship leading
- Walk with and support individuals through challenges of life in all key points of transition
- Co-lead services, including weddings, funerals, baptisms, communion, etc.

### Leadership & Administration

- Support the Congregational Pastor in nurturing an effective team environment
- Work with pastoral ministry team, Church Council and Spiritual Council in the development of ongoing church ministry with a vision for the future

	A support circle will listen to the pastor's needs and concerns and provide the pastor with feedback and encouragement.

Pastors who sense a calling to explore serving with LUMC are encouraged to apply by September 15, 2024. The position is presently open, so a start date is not set. In dialogue, we would work at a mutually agreed upon date.
